# Course and Examination Regulations

Programme-specific section:

## Master's Programme: Latin American Studies

These course and examination regulations have been drawn up in accordance with Section 7.13 of the Higher Education and Research Act [*Wet op het hoger onderwijs en wetenschappelijk onderzoek*] (WHW) (henceforth the Act) and additional quality marks as set out in the framework document Leiden University Register of Study Programmes [*Leids universitair register opleidingen*].

Pursuant to Section 7.14 of the Act the Faculty Board regularly evaluates the course and examination regulations and assesses, for the purpose of monitoring and, if necessary, adjusting the study load, the time it takes students to comply with the regulations. In conformity with Section 9.18 of the Act, the department teaching committee is assigned the task of annually assessing how the course and examination regulations are implemented.

These course and examination regulations consist of two sections: a general section that is the same for all programmes and a section that contains information that is specific to a particular programme. This programme-specific section forms a whole with the general section, and only contains the articles with content that is specific to a particular programme.

## Article 2.1 **Objectives of the Programme**

The programme has the following objectives:

1. to enable students to acquire academic knowledge, understanding and skills, and train them in the use of scientific methods in the field of Latin American Studies;
2. to enable students to develop the following academic and professional skills:
  - independent academic reasoning and conduct,
  - the ability to analyse complex problems,
  - academic reporting;
3. to prepare students for an academic career and further education;
4. to prepare students for a career outside academia.

## Article 2.2 **Specialisations**

## Article 2.3 **Achievement Levels**

Graduates of the programmes will have reached the following achievement levels:

1. Knowledge and Insight
  - a. Graduates possess comprehensive knowledge and understanding of the subjects which are central in one of the three tracks: Public Policy and Social Programmes in Latin America; Cultural Analysis of Image and Discourse in Latin America; and Language Variation and Cultural Change.
  - b. Graduates have knowledge of the most important contemporary theoretical debates within the central theme of the track they have chosen and they are able to critically reflect on those debates.
2. Application of Knowledge and Insight
  - a. Graduates have the ability to analyse the texts which are treated in the track they have chosen in a critical manner and to place these texts in their cultural and historical context.
  - b. Graduates are able to translate the acquired knowledge on key issues and the academic debates around them into relevant research questions, which in terms of content and scope can be studied in an independent research.
  - c. Graduates have a thorough knowledge of up-to-date research methods used in the followed path (such as interviewing techniques, cultural analysis, and so forth) and are able to operationalize this knowledge in an independent way into a concrete and feasible research design.
  - d. Graduates are able to carry out independent research in Latin America and they possess the intercultural skills to work there with relevant individuals and institutions.
3. Judgement
  - a. Graduates are able to make careful considerations about the academic merits and utility of academic arguments and of material that is at the basis of their research and subsequent final report.
  - b. Graduates can form a good judgment about the social, cultural and ethical aspects which should be taken into account when conducting and reporting about their research.
4. Communication
  - a. Graduates are capable of making well-structured and clear oral presentations on an academic subject for an audience of specialists or non-specialists.

- b. Graduates are able to write scientific reports.
- c. Graduates are able to present in a concise and clear manner the subject and the goals of their research to individuals and institutions which can contribute to this research.

#### 5. Learning Skills

- a. Graduates possess the learning skills that enable them to pursue a follow-up study which demands a great amount of self-organization and self-sufficiency, such as writing a PhD thesis.
- b. Graduates are able to apply the acquired knowledge, insights and skills in a work environment, even if it does not totally match the followed disciplinary path or if it is not related to the Latin American region.

#### Article 2.5 **Study Load**

The programme has a study load of 60 credits.

#### Article 2.8 **Language of Instruction**

In compliance with the Code of Conduct regarding Language of Instruction [*Gedragscode voertaal*<sup>1</sup>] the language of instruction and examination of the programme is Spanish. Students are expected to have an adequate command of the language of instruction of the programme.

#### Article 3.1 **Compulsory Components**

3.1.1 The programme includes compulsory components totalling a study load of 60 credits. These compulsory components include the optional courses [*keuzevakken*] from which a student is obliged to choose.

5.2.2 Without prejudice to the stipulations in Article 5.1.1 regarding maximum capacity, persons who do not meet the entry requirements set in 5.2.1 will be granted admission to the programme, if they:

- have earned the degree of bachelor at a university not being a university of professional education, or demonstrate to meet the requirements for such a degree, including the General Academic Skills listed in Appendix C;
- are sufficiently proficient in English, to be assessed by the faculty board (TOEFL 500/173/60 or IELTS 5.0);

- possess comparable qualities in the field of knowledge, understanding and skills with those acquired upon graduating from the bachelor’s programme referred to in article 5.2.1:
  - Elementary knowledge and understanding of the most important cultural and historical developments in Latin America;
  - A sufficient knowledge of Spanish and/or Portuguese;
  - To be able to carry out an independent research in Latin America and to translate the results into an academic report;
  - To be able to deal with theories about the chosen research subject and to apply those theories into a concrete case study.

### Article 5.3 Admission to the academic year 2015-2016

5.3.1 Without prejudice to the stipulations of Article 5.1.1 regarding maximum capacity, persons who are in possession of the following degree are granted direct admission to the programme:

5.3.2 Without prejudice to the stipulations in Article 5.1.1 regarding maximum capacity, persons who do not meet the entry requirements set in 5.3.1 will be granted admission to the programme, if they:

- have earned the degree of bachelor at a university, not being a university of professional education, equivalent to the level of a Dutch academic bachelor’s degree, or demonstrate to meet the requirements for such a degree, including the General Academic Skills listed in Appendix C; and
- are sufficiently proficient in the language of instruction, to be assessed by the Faculty Board (Spanish CEFR listening B2, reading C1; Spanish and/or Portuguese CEFR spoken interaction B2, spoken production B2, writing B2); and
- are sufficiently proficient in English (IELTS 6.0, TOEFL 79-80 (internet-based) or Cambridge English: Advanced (CAE))
- possess comparable qualities in the field of knowledge, understanding and skills with those acquired upon graduating from the bachelor’s programme referred to in article 5.3.1, specifically:
  - elementary knowledge and understanding of the most important cultural and historical developments in Latin America; and
  - the ability to deal with theories about the chosen research subject and to apply those theories into a concrete case study;

Applicants with a bachelor’s degree in International Studies from Leiden University who have completed all area courses for Latin America and the programme’s Spanish or Portuguese language classes are regarded to have fulfilled all entry requirements.
